

Note:

- Fees for 1st Quarter (April to June) would be payable at the time of admission, For 2nd Quarter (July to September) in July, For 3rd Quarter (Oct to Dec) in Oct, For 4th Quarter (Jan to March) in Jan.
- In case of Non- Receipt of fees for two consecutive quarters, a registered notice would be sent to parents by giving them seven days period to pay the fee along with late fees. If they fail to do so, the name of the child would be struck off from school rolls, thereafter.
- Transport fee will be charged according to the route opted for.
- An amount of Rs. 6750 as tuition fee will be charged extra for the month of March as our new session begins in March, and this extra amount will be charged from new admissions one time only.
- The Governing Council reserves the right to increase the school fee as per Government norms, as amended from time to time.
- Fees once deposited for Pravesh Vatika will only be refunded if a parent applies for withdrawal of admission within 15 days from the date of payment. However a deduction of Rs. 20,000/- will be made as administrative expenses and balance amount would be refunded. **No application for refund of admission charges will be entertained after 15 Days from the date of payment.**
- Parent School Committee subscription is to be paid @ Rs. 275/- per child plus GST as applicable.
- Air conditioning charges Rs.800/- PM, will be for April to September (Except for the month of June).
- *Special concession in Developmental Fund available for the wards of Serving Defence Personnel, Central/State Govt. employees (for details please contact school office.)
